

Dear Prospective Men's Auxiliary Member:

The Men's Auxiliary to the VFW has specific criteria that must be met to be eligible for membership that is recognized by the National VFW.


You will have to provide a Form DD-214 or other verification that shows that the relative you are applying under was qualified for regular membership for the VFW, or is a member of the VFW. This information will be checked against a list of eligibility criteria that was established by the United States Congress. You must be a husband, widower, father, grandfather, son, grandson, brother, or half-brother of a qualified veteran in order to be eligible. If you are transferring from another post, we will also need a copy of your Auxiliary Membership Card. Members may not be less than 16 years of age.

The current dues for the calendar year is \$27.00. Checks should be made payable to *Charles Evering VFW Post 6506 Men's Auxiliary*. You may submit payment, with the completed application below and necessary documentation to any officer, or deposit them in the *MEN'S AUXILIARY* mailbox located by the raw bar at the post. Pending verification of your documentation, your Permanent Membership Card may take 6-8 weeks for processing.

Key Cards, which allow you access without "buzzing in" - are available from the Bar for a nominal fee.
